DECLARATION OF PATRICK PERKINS

I, Patrick Perkins, declare as follows:

- 1. I am currently employed as Senior Vice President, Chief Intellectual Property Counsel for Warner Bros. Discovery Inc. and among my responsibilities is anti-piracy enforcement for Home Box Office, Inc. ("HBO"), a corporation duly organized and existing under the laws of the State of Delaware, having its principal place of business in New York, New York. HBO and certain of its affiliated companies, are engaged in a variety of businesses including, without limitation, the production and/or distribution of television programs. HBO owns exclusive rights under the Copyright Act in and to its works.
- 2. HBO is requesting the attached proposed subpoena pursuant to 17 U.S.C. §512(h) that would order Reddit, Inc. to disclose identifying information for the operators of the user names infringing HBO's copyrighted works as identified on the attachment to this declaration, from any and all sources, including but not limited to from billing or administrative records that provide the name(s), address(es), telephone number(s), email address(es), account number(s) and any other electronic or physical names, addresses, IP addresses, or contact information.
- 3. The purpose for which the subpoena is sought is to obtain the identity of the alleged infringers and the information obtained therefrom will only be used for the purposes of protecting the rights under 17 U.S.C. §101, et seq.
